Official Rules for the ADA 2025 Level Up Promotion

No Purchase Necessary. A Purchase Will Not Increase Your Chances of Winning.

- Eligibility: The ADA 2025 Level Up Promotion ("the Promotion") is open only to D4 dental students
 who are graduating from a CODA-accredited dental school in 2025 and who have completed and
 submitted the ADA National Signing Day form between January 1 and June 30, 2025. ADA officers
 or trustees and their immediate families and household members are not eligible to receive a
 prize.
- 2. **Entry Period:** The Promotion begins on May 1, 2025 and ends on June 30, 2025 (the "Entry Period"). Entries received before or after the Entry Period will not be eligible.
- 3. **Prizes:** Fifteen (15) one-year premium MasterClass continuing education subscriptions will be awarded. Each annual subscription is valued at \$120.00.

4. How to Enter:

- a. **Automatic Entry:** Completion and submission of the 2025 ADA National Signing Day form indicating post-dental school plans and updating contact information will result in automatic entry into the Promotion.
- b. **For all Entries:** By entering, you indicate your full agreement to these Official Rules and ADA's decisions regarding the Promotion, which are final and binding. Winning a prize is contingent upon fulfilling all requirements in these Official Rules.
- 5. **Drawing:** On or about July 15, 2025, ADA will select fifteen (15) potential winners in a random drawing of all entries received by the closing of the Promotion's Entry Period. Each winner selected will receive a single one-year MasterClass continuing education subscription once all requirements stated in these Rules have been met. The odds of being selected depend on the number of entries received.
- 6. **Potential Winner Requirements:** Except where prohibited, a potential winner may be required to complete and return a declaration of eligibility and liability/publicity release. If a potential winner fails to sign and return these documents within the required time period or if a potential winner is no longer an ADA member in good standing at the time of the drawing an alternate potential winner may be selected in his/her place in a random drawing of all remaining entries received.
